SUBJECT: Finance Board Approval Request – TSA Terminal Lease Space Renewal

The Burlington Airport seeks Finance Board and City Council approval and authorization for the City to enter into a lease agreement for office space within the terminal building.

The TSA is seeking renew a lease agreement with the City of Burlington for the lease of 2,860 square feet of office space within the terminal building. The lease rate will be \$51 per square foot and will increase annually by the annual change in CPI.

The lease will begin on July 1, 2013 and expire on June 30, 2016. The lease will also contain a mutually agreeable renewal term for another three years at the same lease rate and begin on July 1, 2016 and expire June 30, 2019.

The Airport Commission approved the Easement agreement on June 12, 2013.
