CHAIR'S REPORTS

1. Discussion with First Night Burlington

- Website has new accessibility section.
- New mobile application will make accessing website easier
- 17 of 18 sites are accessible by wheelchair and each site has designated parking for folks who are
 disabled. A variety of performances will be interpreted for the deaf and hard-of-hearing by
 American Sign Language interpreters. The Flynn Center Main Stage is equipped with an infrared
 hearing reinforcement system for the benefit of audience members with hearing disabilities.
 Contois Auditorium in City Hall is equipped with a hearing assisted sound system. 242 Main is not.
- Shows featuring ASL interpreters include Circus Smirkus, 1:00 pm; Singalong with Robert, Megan and Emer, 2 PM; Jernigan Pontiac, 3 PM; Kat Wright & the Indomitable Soul Band, 6 pm; A2VT, 7 pm; Family Friendly Comedy with Dustin Bruley, 8:00 pm, The House of LeMay, 9:00 PM; Christian McBride, 10:00 pm.
- Sarah is holding site manager trainings at each of the 18 venues; site managers will then train the volunteers.
- Sarah will put out a Survey Monkey to get feedback as to what can be done better next year.
- Patrick Standen discussed his and others challenges faced in a wheelchair during First Night when it snows before or during snow storms. Recommended that new ways be considered for snow and ice removal on sidewalks
- Ralph, Patrick and committee members will draft a letter to the Mayor and the Director of Public Works, to request special attention to public sidewalk between venues the First Night venues.
- Patrick discussed ADA requirements for a non-profit organization. Group discussed what is First
 Night's responsibility for accessibility as a non-profit, which does not own or manage the majority
 of its venues. Religious institutions are exempt from ADA but ones in Burlington exceed
 expectations. It was agreed that ADA rules are not clear around this. Group discussed the
 definition of "undue burden" or significant difficulty or expense, per the ADA.
 - (1) nature and cost of action needed under this part; (2) overall financial resources of site or sites involved in the action; the number of persons employed at the site; the effect on expenses and resources; legitimate safety requirements that are necessary for safe operation, including crime prevention measures; or the impact otherwise of the action upon the operation of the site; (3) geographic separateness, and the administrative or fiscal relationship of the site or sites in question to any parent corporation or entity; (4) If applicable, overall financial resources of any parent corporation or entity; the overall size of the parent corporation or entity with respect to the number of its employees; the number, type, and location of its facilities; and (5) If

applicable, type of operation or operations of any parent corporation or entity, including the composition, structure, and functions of the workforce of the parent corporation or entity.

 Michael Watson asked that we communicate to DPW that they not use the downtown's handicap spaces as temporary snow dumps.

2. Ad Hoc Committee Updates

- Special thanks were given to Brad Stephenson and his team for the work done with First Night Burlington.
- Formation of a Media Committee was discussed. Ralph discussed Shelly's interest in forming a
 media committee and about the "how to's" of creating public service announcements. Group
 brainstormed different ideas for a public service announcements and determined it would be
 important for Shelly to be part of future discussions.
