Overview:

Parks is proposing 10 vehicles/equipment purchases for a total investment of \$343,974.95. All vehicles and equipment were competitively bid following the protocols established through DPW's equipment and vehicle maintenance division. All vehicles and equipment selected met specifications and were the low bids.

Vehicle Notes

There are 25 vehicles in the fleet. Our primary goal is to remove vehicles greater than 10 years old and to adopt a replacement program that adheres to that.

Investment has not been able to keep up with the number of vehicles requiring replacement (see Inventory Replacement Program Spreadsheet). We estimate that about a quarter of the backlog will be taken care of through this plan, and we are careful not to introduce over 25% so that the City isn't burdened with a significant replacement cost in ten years.

- With trade value included the total investment for 5 vehicles is \$164,847.62
- Five current fleet vehicles will be replaced in this proposal.

- By borrowing money directly from the City, the Department has decreased it's rent/lease by almost \$15,000 from FY14 to FY15.
- We will be able to reduce the operating expenses associated with repair and maintenance through DPW.
- Newer vehicles are more fuel efficient and expanded vehicle/equipment reduces the need for transportation across town.
- Additional equipment reduces down time for repair thus improving staff efficiency.
- This is a prime time for vehicle trade in as current values are high, waiting another year would reduce the value of trade and increase the expense of outright purchase.
- This plan increases our purchasing power and keeps all the money inside the general fund.
- Parks currently has a Greenbelt Fund Balance of over \$190,000. The remaining balance will be needed in FY15 to replace the tree division bucket truck.
- The annual payments will be made out of Parks Administration which has approximately \$60,000 in available annual appropriation.

Equipment Notes

There are 14 pieces of equipment in the fleet that are considered large equipment because of their cost. This list includes wood chippers, trailers, tractors and large mowers.

The total investment is proposed for \$179,127.33 for 5 pieces of large equipment. The goal of the Department is to increase the fleet of large equipment for the following reasons:

- Get the right machine for what you want to do. Many machines have attachments or are built to perform certain, but not other tasks. With the diversity of tasks we perform, we need to make an effort to have the right equipment so we don't damage or cause harm to other pieces.
- There has been a significant investment in athletic field construction. Older machines have tendency to leak harmful fluids on the turf, or cut unevenly. We have prioritized having the right machine cutting turf on our athletic fields to help provide the safest surface possible. We will also repurpose our current tractor inventory to specialize in field maintenance operations such as over seeding, aerating, and dethatching tasks that improve and keep our fields safe.
- Since 2013 the Department has increased the amount of property we maintain via the Water Department (DPW) as well as our laboring capacity through the Bike Path Maintenance fund (one FTE and two temporary positions). This equipment will also be able to accommodate the

needs of those two programs, and free other equipment up for beach maintenance and the seasonal event operation and marina.

• We have explored equipment sharing and regularly partake in this exercise and discussion. The listed equipment and vehicles are either unique to park job tasks or would be needed at the same time Departments would need these vehicles.
