Jonathan and Ken,

Attached please find drafts of a City Council resolution regarding amending Condition 17 of BT's CPG and an MOU between BT and the CAO re: PILT.

I also located my previous opinion on the applicability of Section 109 of Title 30 to financings, which was as follows:

"This firm's opinion is that the capital lease between the City and Koch Financial does not constitute a "lease" under Sections 109 and 232 of Title 30, Vermont Statutes Annotated and, therefore, Condition 3 of the CPG is not triggered by the City's plans to borrow additional funds from Koch. When read in their entirety, the plain language of Sections 109 and 232 require Board approval for sales, leases or other transfers of 10% or more of a regulated utility's property to another entity within a calendar year. They do not apply to the subject capital lease because it does not amount to a conveyance of title to BT's property to another entity. See Krulee v. F.C. Huyck & Sons, 121 Vt. 299 (1959) (holding that section 109's predecessor requires Board approval to "convey a clean and marketable title . . ."). Condition 3 applies only to situations where BT transfers its physical assets, including those subject to the capital lease with Koch, to another entity. Since no transfer or conveyance is involved, Condition 3 of the CPG is not triggered."

I will stick by this opinion.

I believe this is everything on my list from this morning's meeting. I will work with Amber to prepare a petition for filing with the PSB by September 13, 2008.
