### **MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding (the "MOU"), dated as of May \_\_\_, 2009, is between the Vermont Department of Public Service (the "DPS" or "Department") and the City of Burlington, Vermont d/b/a Burlington Telecom ("BT" or "Burlington Telecom").

### PRELIMINARY STATEMENT

Burlington Telecom owns and operates a cable-television system serving the City of Burlington, Vermont. Under its Certificate of Public Good ("CPG") issued in Docket No. 7044, specifically Condition No. 17, BT was required to "build its network to serve every residence, building and institution in the City of Burlington within thirty six (36) months of the date of [the] CPG" that was issued on September 13, 2005. Recognizing that it would not complete the build out of its system to serve every residence, building and institution by September 13, 2008, BT filed the subject petition on September 10, 2008.

BT proposes to complete an audit of the yet to be served residences, buildings and institutions in its service territory and, based upon the results of that audit, develop engineering plans and cost estimates for serving those potential customers and completing the build out of its system. BT and the DPS enter into this MOU to stipulate to the time line for completion of the audit, development of engineering plans and cost estimates and construction of the remainder of

BT's system so that it can serve every residence, building and institution in the City of Burlington. The parties also stipulate to the appropriate penalty for BT's failure to complete the build out of its system within 36 months as required by Condition No. 17 of the CPG.

NOW, THERFORE, the parties hereto agree as follows:

- 1. Burlington Telecom shall complete an audit of every residence, building and institution presently not served by BT's system, including a description of whether the location can be served by public right-of-way or whether a private right-of-way is necessary, by June 30, 2009. The audit will be based upon 911 and internal data of BT.
- 2. Burlington Telecom shall complete engineering plans and cost estimates for serving those residences, buildings and institutions identified in the audit required by paragraph 1 above by July 31, 2009. The engineering plans required by this paragraph shall identify the least cost plan for serving each location.
- 3. Burlington Telecom shall provide the Department with monthly updates on the progress of its audit and engineering plans and cost estimates until completion. BT shall be entitled to seek confidential treatment of any filings made pursuant to this MOU.
- 4. By June 1, 2009, Burlington Telecom shall provide to the DPS an unaudited list of all streets and other areas of the City not constructed as of the close of the 2008 construction season, which will include an explanation of the reasons why they were not constructed in previous seasons.
- 5. Before August 31, 2009, the Department and Burlington Telecom shall meet to review the results of the audit and engineering plans and cost estimates. By that same date, BT shall propose to the Board a date by which BT will complete construction of its system.

- 6. Burlington Telecom shall file a line extension policy consistent with the requirements of Board Rule 8.000 on or before June 1, 2009.
- 7. Until such time that BT has satisfied its obligations under Condition No. 17 of its CPG as modified by this MOU, BT shall continue to file the line extension reports with the DPS by April 15 of each year as specified in Condition No. 17.
- 8. As a penalty for failing to complete the build out of its system as required by Condition No. 17, BT shall use its best efforts to obtain full RUS funding for the build out of its system to unserved areas of the State of Vermont as identified by the DPS and Office of Economic Stimulus and Recovery.
- 9. The parties hereto agree that the Board may issue the final order in this docket attached to this MOU as Attachment 1.
