PETITION

By this petition, the City of Burlington d/b/a Burlington Telecom, represents:

- 1. It holds a Certificate of Public Good ("CPG"), issued in Docket No. 7044, to operate a cable television system in the City of Burlington, Vermont and as such is subject to the Vermont Public Service Board's ("Board") jurisdiction.
- 2. Comcast of Connecticut/Georgia/Massachusetts/New Hampshire/New York/North Carolina/Virginia/Vermont, LLC ("Comcast") also provides cable television service within the City of Burlington.
- 3. Condition No. 17 of its CPG requires Burlington Telecom to "build its network to serve every residence, building and institution in the City of Burlington within thirty six (36) months of the date of [the] CPG" that was issued on September 13, 2005.
- 4. As of September 13, 2008, Burlington Telecom will have built its network to serve over ninety (90%) percent of the residences, buildings and institutions in the City of Burlington.
- 5. The remaining residences, buildings and institutions still to be served consist of public and private property and the downtown commercial core.



- 6. These remaining residences, buildings and institutions have not been denied cable television services in that they presently have access to service provided by Comcast.
- 7. In June 2007, the Burlington City Council authorized Burlington Telecom to pursue a strategy of financing approximately ninety-five (95%) percent of the build out, with the remaining 5% to be built out as revenues from Burlington Telecom allow.
- 8. Burlington Telecom seeks an amendment to Condition No. 17 deleting the first sentence and replacing it with a statement that Burlington Telecom will build out the remaining sections of the City of Burlington as revenues provide.

WHEREFORE, Burlington Telecom respectfully requests that the Board:

- A. Schedule a prehearing conference and workshop to allow Burlington

 Telecom to present its progress to date in building out the City of Burlington, and its

 plans for building out the remaining portions of the City of Burlington;
- B. Establish a date for a further status conference in this proceeding, at which time either Burlington Telecom and the Department of Public Service will file a stipulation resolving the issues in this matter or, if a settlement cannot be reached, a proposed schedule for investigating the issues raised by this Petition; and
- C. Take such other actions as and or may be necessary to amend ConditionNo. 17 of Burlington Telecom's Certificate of Public Good.
