In the year Two Thousand Ten.....

Resolved by the Board of Civil authority of the City of Burlington, as follows:

That WHEREAS, the City of Burlington Special City Election Meeting occurred on November 2, 2010 along with the State of Vermont General Election; and

WHEREAS, state statute, 17 V.S.A. §2454, requires the appointment of a sufficient member of assistant election official for each voting district by the Board of Civil Authority with an attempt to appoint an equal number of persons from each major political party; and

WHEREAS, due to circumstances beyond officials’ control the Board of Civil Authority was unable to appoint such assistant election officials prior to the election; and

WHEREAS, ward clerks as presiding officers of their voting districts did find sufficient persons of varying political affiliations to serve as assistant election officials for their districts; and

WHEREAS, these persons did serve under the direction of the ward clerks as assistant election officials, providing competent and essential assistance to the elected ward officers in the running of the November 2, 2010 election;

NOW, THEREFORE, BE IT RESOLVED that the Burlington Board of Civil Authority, in accordance with state law, ratifies the appointment of the following assistant election officials with the said appointment to be in effect for only the November 2, 2010 Special City Election and the State of Vermont General Election:
